Maidstone Council signs off first group of Local Plan policies

Maidstone Council has signed-off a suite of Local Plan policies in its next step towards approving the guidelines that will shape the development of the borough for the next 20 years.

Cabinet members were presented with 14 development management policies, which set high standards of design for the borough and the town centre.

They included criteria around the principles of good design for residential and economic development, and open spaces; sustainable design standards; guidance on the look of shop fronts and shopping areas; and requirements on residential extensions, conversions and redevelopment.

Two new policies were also put before members, which respond to emerging planning issues identified by the Planning, Transport and Development Overview and Scrutiny Committee and council officers.

New rules on renewable and low carbon energy schemes, such as solar farms and wind turbines, will be particularly welcome to rural communities in the borough. The guidelines state schemes must be appropriately sited and not conflict with landscape character or existing uses.

The policy also lists the requirements developers will need to demonstrate have been taken into account, such as noise, visual and heritage impact.

Policy DM8 addresses non-conforming uses in the borough and has been included to shore up policy around determining planning applications for activities that may impact negatively on residential amenity, landscape or ecology because of noise, noxious odours or increased traffic, particularly in rural areas.

Council officers will be presenting the next group of Local Plan policies, which will deal with development in the countryside, economic development, the town centre and urban areas, and affordable housing, at the Overview and Scrutiny Committee on 19 November and subsequently to the Cabinet on 4 December.

The Local Plan will help control the type and design of developments throughout the borough and protect our most valued countryside as well as outline the sites earmarked for potential development.

Unfortunately, we had to cancel our Task Days for this month, due to persistent rain.

Our next Task Day will be on the **3<sup>rd</sup> November**, to try and finish off our North plateau work. As we said at the start of the year, our Task Day for November would be early because of Remembrance Day being on the second Sunday. So, I look forward to seeing you on the 3<sup>rd</sup>.

There has been a major drive towards raising extra funding for the chipper this month. Applications were submitted to Kent County Council, Boxley Parish Council, Southern Water and hopefully, very soon, the Forestry Commission. For the chipper and everything else that has to go with it, we need just under £10,000. If we are successful with all our applications to date, we will have raised £6,500. I am now fully trained as a Heritage tree surveyor, which means I can now nominate trees for the national Heritage tree list. If you know of any trees locally, which you think may be of significance, and could be candidates for the list, please let me know.

Two members of our group are now qualified and certified, to use brush cutters. This should make us even more effective in the work we can perform.

In spite of the cancellation of our Task Days this month, we have managed several major jobs during the week, this month:

• removed major fallen trees from across the path in Tunbury valley;

- made safe two hung-up trees, also across Tunbury valley path;
- made a new (alternative) path around the bog near by the crossroads in Tunbury.

If anyone requires more information about any work we do during the week, please let me know. We held our AGM on the 17<sup>th</sup> September at Beechen Hall, the minutes for which are available. If anyone would like a copy, please let me know.

Just to give you plenty of warning, we are holding our quarterly meeting at Beechen Hall, on December 9th at 4pm.
