Item 4 Matters Arising from the Minutes. Purpose of item: INFORMATION AND DECISION

Minute 4.1 HGV parking. The following is an update on the work that Helen Whately MP has been doing. (E-mail 16.03.16). Further information has been requested on the issue regarding criminalisation of parking and toll fees to allow collection from foreign operators.

"At a meeting with Andrew Jones at the Department of Transport I asked whether foreign HGV drivers are paying their fair share for using UK roads.

I've now received a letter from the Under Secretary of State, which you can read by clicking the attachments below.

He tells me that since it was introduced on 1st April 2014, the Levy has raised a total of £192.5 million, of which £46.5 million came from foreign registered HGVs. It was estimated to raise £21 million from foreign vehicles, so this is good news.

British lorry drivers felt that it's unfair that they paid to use roads abroad but foreign hauliers didn't pay to use British roads. As a result the Coalition Government introduced the HGV Road User Levy so that drivers of heavy vehicles contributed to the upkeep of our roads.

The Levy applies to both British and foreign HGVs, but the previous Government reduced Vehicle Excise Duty for British lorries at the same time, so UK lorry drivers would not have to pay more".

Thank you very much for coming in for the meeting on 16th September to discuss transport issues in Kent.

In our discussion you queried whether foreign HGVs are paying their fair share for using the UK's roads, and I undertook to update you on the HGV Levy which we introduced last year with than in mind.

Since 1st April 2014 all HGVs at or above 12 tonnes gross weight using UK roads have been required to pay the HGV Road User Levy. The Levy ensures all such HGVs contribute to the costs of UK road maintenance. The idea is to remove some of the inequality UK hauliers feel when paying to use many roads abroad. The Levy costs up to £10 per day or £1,000 per year.

While UK vehicles must also pay the Levy to keep it in line with European legislation, for most UK-registered HGVs vehicle excise duty (VED) has been reduced so they do not face additional costs. For simplicity, they pay the Levy alongside their VED.

In its first year of operation the Levy raised a total £192.5million in receipts, of which £46.5million was from foreign-registered vehicles and £146million from UK-registered vehicles. Receipts from foreign vehicles were significantly ahead of forecast which had been of the region of £21m per year. This has arisen from higher numbers of vehicles coming to the UK than we had estimated, and the fact that most operators are not buying the best value (long-duration) Levies. Enforcement has also been a good-news story, with the Levy compliance level for foreign vehicles in Great Britain steady at around 95%.

Dennis Hollands site visit report, Court Lodge Farm, The Street (old barn and area beside The Granary and adjacent to the church graveyard).

I attended the site visit due to my Parochial Church Council Chairman role as there might be an issue with the wall between the barn and the graveyard and I asked that the Clerk also accompany me. As members' are aware the owner Graham Maskell has been given planning permission to develop the area and it was an extremely interesting visit especially as he had bought along the plans and also spoke of future plans. I have therefore suggested that at some point a site visit is arranged with the Environment Committee so that they can see what is on the ground and what is planned for the future. I have left this with Graham and the Clerk to arrange when it is needed.

Item 7 Highways and Byways. Purpose of item: Decision/guidance

Item 7.1 Bollards on verge adjacent to Boxley Rd/Travertine Rd junction.

KCC Highways has informed the parish council that it will only allow approved contractors to work on its verges and, in this instance, it is now willing to allow bollards to be installed.

Members' previous statement on the action needed was that the parish office was to obtain costs for installing bollards on the verge to stop parking. To stop parking KCC Highways states that 16 bollards should be installed and two quotations to a) supply and fit bollards and b) to fit bollards only have been received from the approved KCC Highway contractor.

The cheapest option, if members want 16 bollards, is for the parish council to purchase the bollards and reflectors and arrange for them to be installed, at a cost of approximately £1,220. For the KCC Highway's contractor to do all the work will cost £3,121. A cheaper "supply and install" quotation has been received from a local firm however it is not clear if this firm is recognised by KCC Highways to allow them to undertake the work. A response is awaited from the firm.

Any damaged bollards will have to be replaced by the parish council however the KCC grass maintenance regime allows for strimming around bollards installed in verges.
