Members raised concern about the inappropriate description of the Ash Tree which are considered to be extremely valuable trees.

Lengthy discussion took place as members felt that the development might have already taken place as a large imposing structure could be viewed from PRoW KH32. Concern was raised about over development of the site and adverse impact on the street scene from the rear and possibly also the front of the property.

pathology laboratories (class B1); business uses (class B1); ancillary retail services (class A1, A2, A3); and up to 116 bed class C2 neuro-rehabilitation accommodation; internal roads and car parks, including car park for residents of Gidds Pond Cottages; hard and soft landscaping including creation of a nature reserve (to renew existing consent 13/1163) - condition relating to

limited only to occupiers directly associated with the life science, health care and medical sectors. Newnham Park Bearsted Road Weavering Kent. Deadline 16 February 2018

Clerk's note: The above description on the application gives no clue (as it reproduces the description from the previous applications) as to what the applicant wants to replace the condition with.

Condition 37 of 16/507292/OUT

The occupation of any B1(a) office buildings and (B1(b) research and development buildings hereby permitted shall be limited only to those occupiers directly associated with the life science, health care and medical service sectors, and for no other purpose (including any other purpose in Class B1 of the Schedule to the Town and Country Planning (Use Classes) Order 1987 (as amended) or permitted under the provisions of the Town and Country Planning (General Permitted Development) Order 2015 or any

statutory instrument revoking and re-enacting those Orders with or without modification;

Reason: To ensure the development remains a mixed use and medical-based development in accordance with draft policy RMX1(1).

Clerk's note: The supporting letter, which is quite long, gives examples of the types of businesses in Kent Science Parks and implies (see extract below) that this is what the owner wishes to attract however the removal of condition 37 would allow standard and non-medical related offices, research and development.

However, the current wording of the condition would prevent other businesses who would benefit from being co-located with medical companies from occupying even a small part of the KMC facilities, even though such co-location would be mutually beneficial. It also prevents the use of the site by small start-up businesses if these are not directly associated with the life science, health care and medical sectors, even though the provision of such floorspace would benefit the local economy.

Item 9 Highways and Byways - INFORMATION

- 9.1 Yellow lines at junctions on Provender Way. MBC, KCC. Cllr Hinder's meeting with County Councillor Paul Carter has raised £2,000 from his devolved budget to pay for some yellow lines at the junction. St John's School has been contacted and a list of the worst junctions has been requested. It is not currently clear how far this funding will go.
- 9.2 The yellow lines at Provender Way have been repainted after the parish office asked for the work unfortunately it appears that they are being ignored by inconsiderate drivers. MBC has been asked to enforce them. MBC refused to yellow paint a bus box as it was a request bus stop, this decision has been challenged by the parish council. Update to be supplied at meeting.
- 9.3 Chatham Road design, Sandling. The work is programmed for April. Due to the layout and length of the road there will need to be a closure for a period of time and also traffic control and periodic temporary closures. Local residents will be receiving leaflets from KCC
- 9.4 Solar powered sign south of M2 bridge Lidsing Road. Response received from Matt Watson Senior Network Response Officer KCC.

We have a flashing speed sign in this location which should illuminate if a vehicle is approaching in excess of the speed limit.

I will arrange for an engineer to attend and check the sign. Our reference for this is TR 917812.

Councillor Bob Hinder has contacted Helen Whately to thank her for her support but also to point out that the "adjusting" of the traffic light sequence has not been working as traffic exiting or wanting to access the M2 are stopped by other queuing vehicles.

Thank you for your letter of 6 December 2017, enclosing correspondence from Mr Bob Hinder, Chairman of Boxley Parish Council, Beechen Hall, Wildfell Close, Walderslade, Chatham, Kent ME5 9RU, about congestion around junction 3 of the M2 and the impact of the new Lower Thames Crossing.

Highways England are aware that M2 Junction 3 has exceeded its design capacity and carries more traffic than the junction and surrounding local road network were ever intended to handle. In this context, there is a need for improvement and Kent County Council (KCC), which manages the local road network, are considering options. In the meantime, they are continuing to monitor and adjust the traffic light timings to achieve a better balance for the local roads that join the junction. The timing is set up to minimise queuing on the motorway slip roads for safety reasons. Highways England will work with KCC on any improvement schemes it identifies.

The economic assessment that informed the selection of the preferred route for the Lower Thames Crossing included traffic forecasts for affected roads, including the M2. This high level appraisal was reported in section 4 of the Post-Consultation Scheme Assessment Report Volume 5.

Highways England are now undertaking more detailed consideration of the traffic impacts of the proposal across the local and strategic road networks. This includes producing comprehensive forecasts of traffic volumes and journey times based on updated travel demand data. This will inform detailed design of the scheme and will be published in 2018, ahead of the scheme's statutory consultation. This work will also inform Highways England's regional route planning, ensuring a comprehensive and co-ordinated assessment of the impacts.

Item 10 20mph speed limits - Review and decision

Clerk's note.

Cllr Ivor Davies notified the office of a Jan 2018 report in The Telegraph concerning a review of the 20mph speed limit introduced by Bath and North East Somerset Council (B&NES). Extract from the articles

"'Safer' 20mph zones led to rise in number of road deaths but too costly to reverse, council admits

Reducing the speed limit to 20mph has caused a rise in death and serious injuries, a council has admitted, but is refusing to reverse the scheme because it will cost too much.

Bath and North East Somerset Council spent £871,000 bringing in the 13 new speed zones just 12 months ago. But one year on, a report has found that the rate of people killed or seriously injured has gone up in seven out of the 13 new 20mph zones.

The review of the traffic control measures warns that this is a problem nationally, adding: "There is no simple explanation for this adverse trend but it could be that local people perceive the area to be safer due to the presence of the 20mph restrictions and thus are less diligent when walking and crossing roads, cycling or otherwise travellina."

Despite the council's own report concluding that there is "little in the way of persuasive argument for continuing the programme in the future", deputy leader Patrick Anketell-Jones has admitted there simply isn't the money available to reverse the 20mph zones".

B&NES report Setting Local Speed Limits. A review of recent installations of 20mph area schemes (signage only)

Clerk's note. The report was undated and could not be found on the B&NES website, a copy was found on a bloggers page and as it reflects what was reported in The Telegraph and as internet comments and local newspapers seem to quote from the report it is being taken as the report that B&NES produced.

The report contains various statistics and analyst and the following information/quotes are taken from the report when shown in italics. In the statistics tables blue colouring indicates an improving situation with yellow indicating a worsening one (an increase in "KSI" which refers to the casualty classifications "killed or seriously injured"). The following is a summary of the statistics in the report.

Chapter. "Change in casualty severity"

"In this analysis, the picture has changed substantially. Three areas have remained constant with zero KSI rates, but now the yellow changes outweigh the blue by 7:3. [Clerk's note the previous year summary stated "the blue cells outnumber the yellow cells 8:5,"] This suggests that, overall, the schemes have seen a worsening of the casualty severities, although the control area also shows the same trend.

Nationally, this adverse trend is also prevalent in other authority areas. In one notable case in Portsmouth, one of the earliest area based projects, it was reported that "the number of people killed or seriously injured actually went up, not down, after the limit was lowered". There is no simple explanation for this adverse trend but it could be that local people perceive the area to be safer due to the presence of the 20mph restrictions and thus are less diligent when walking and crossing roads, cycling or otherwise travelling".

Chapter. Conclusions.

The study has found that,

a) Broadly speaking, speed reduction in line with national trends has been achieved, but in real terms the overall reduction in average speed is very small (1.3 mph) and thus is not persuasive in terms of the money spent on these schemes.

- b) Some accident reduction has been observed in Bath, but accident increase, albeit slight, has been seen in outlying towns. Again, this mixed outcome seems to be reflected across the country.
- c) Casualty severity has worsened marginally in Bath and more so in outlying towns. Again, this is reflective of the national situation for reasons which are not yet clear. A number of the schemes have not yet been in place for 3 years and thus the casualty picture might alter over the remaining months.
- d) Overall, the speed limit programme in B&NES seems to have provided little in the way of persuasive argument for continuing the programme into the future.
- e) Indeed, the rise in casualty numbers and severity as per the national trend (albeit with relatively small numbers in B&NES) would suggest against further expansion of area based schemes.
- f) This analysis could be updated when all areas have 36 months of after data available and in the light of the anticipated DfT study on this subject (expected in 2017).

Clerk's note. A 2017 report could not be located on the Department for Transport site but The Telegraph had a previous article on 3 July, which contained the following information. A full copy of the articles can be supplied to members on request. It is important to highlight that the second article (below) did have quotes that residents needed to be consulted on what they want as in some cases local authorities were not undertaking consultation.

"Most drivers ignore 20mph speed limits, official figures show

Twenty mph speed limits are ignored by more than eight in ten drivers, new official statistics suggest. Figures released by the Department for Transport show that 81 per cent of cars recorded at nine sites across the country in 2016 broke the limit, with a handful - 15 per cent - travelling at more than 30mph".

"Twenty mph speed limits have been in place in the UK since 1991, with 250 introduced by the end of the decade. The law was then liberalised to gave local highway authorities the flexibility to impose limits without applying for permission from central Government, as well as introducing traffic calming measures such as speed humps within the zones.

Many 20mph zones now come with speed humps, however last year the National Institute of Health and Care Excellence (NICE), which sets NHS treatment policy, called for them to be scrapped on the basis they increase pollution".

The intervention followed a study by Imperial College London which found that forcing drivers to slow down and speed up again results in notably more harmful emissions".

Item 11.1 Street Maintenance policy and pro forma (review).

Encroaching vegetation from private property. The Highway Authority can send a letter requiring the work be done and this can be arranged via the Highway Inspector². Alternatively the parish council will send its own letter.

Footways, especially if on a school, cycle or access to public facilities route are considered a priority by the Environment Committee. Salt bins are now only supplied if the County Councillor pays for them.

Vision splays are a H & S issue if they are overgrown and should be cut as and when required. This is the same as vegetation around speed signs and highway directional signs. KCC now works to a safety critical policy³ which often means work requested is refused.

When considering projects Environment Committee should consider the following

- Whether the request is commensurate with the possible cost.
- H & S issues if it is going to arrange for work to be done.
- Who uses the footway, footpath etc?
- Why is it used (does it connect to a bus stop etc.)?
- Benefit to the wider community.
- Is it a 'make it pretty' request or a practical request?

There is a limited budget for work and where possible problem areas will be given priority. The Environment Committee can consider work for aesthetic reasons but these should not take priority over work needed for practical reasons. Funds will be normally be released in quarterly amounts.

Street Maintenance Procedure for submitting projects for consideration.

Members identify precisely what work they want done. Where possible this is to include site plans, approx.. measurements and photographs.

The request is submitted to the Environment Committee to decide whether they agree in principle to the project, at this stage it might be possible to give an indication of cost of the work.

The parish office will work with the members to draw up a job specification.

Quotes can then be obtained and the Environment Committee can then agree whether to fund the project. The office will then obtain any permissions required or arrange the work.

General advice.

Use common sense. Just because one person has spoken about an issue does not mean that everyone else wants the action. Beware of a complaint about a private property there may be a neighbours dispute going on so just keep to facts.

Boxley Parish Office Risk Management for litter picking by volunteers.

All volunteers should read and follow this safety advice

Risk	Area of Risk	Specific issues.	Potential Mitigation
	Medium reduced to low if instructions and advice followed.	Rough land, rubbish, broken footpath surfaces etc. Wet grass or surfaces.	Proper and sensible footwear must be worn. If working adjacent to an open road then a fluorescent jacket will be provided and must be worn. Ultimately it is up to the volunteer to take care and look for any potential hazards and either arrange for their removal or a repair by contacting the parish office. A volunteer should only collect litter within arm reach using a litter picker and only if it is light enough to pick up without causing the volunteer to slip or be pulled over. Volunteers are advised not to walk into bushes or shrubbed areas and should watch for any branches over overhanging vegetation that might be at face/head height.

Working adjacent to roads	Medium reduced to low if instructions and advice followed.	Being hit or clipped by a passing vehicle.	The parish council would prefer no volunteers to work in a road as they are safer working from footways. Collecting should be done in good light and volunteers should collect walking towards the on-coming traffic. Fluorescent jackets must be worn at all times. Care should be taken at all times to avoid unexpected incidences such as: pulling at rubbish and losing one's balance; on narrow footways watch for any over lapping lorry wing mirrors; collecting litter from a road gutter may bring you into conflict with cyclists and vehicles so always check what traffic is heading your way before putting the litter picker into the road. You may be working on a cycle/footpath so ensure that you are vigilant and watch for any cyclists.
Cuts from 'sharp' materials.	Medium reduced to low if instructions and advice followed.	Items left by public	Broken glass can rip through plastic bags so it is preferable that any glass is placed within a cardboard box, so it is good to take something like an empty cereal box with you, or leave the broken glass alone and instead report its location to the parish office. ANY INCIDENCES OF SYRINGES OR NEEDLES MUST IMMEDIATELY BE REPORTED TO THE PARISH OFFICE AND POLICE.
Clearance of dog mess - infection	Medium reduced to low if instructions and advice followed.	Dog waste not being cleaned up or left in plastic bags at the site.	Volunteers should not clean up any unbagged dog waste.
Strains .	Low/Medium.	Strains from leaning over or overfilling bags.	Volunteers should not attempt to lift or carry heavy flytipped items or bags. Large flytipped items can be reported directly to MBC via its website or to the parish office.

Any cuts, accidents etc. must be reported to the parish office who will arrange for an accident report to be completed.
