16/502988/TPO TPO application to 2no Sweet Chestnut - Fell, 6no Sweet Chestnut/Maple - Cut back to boundary line, 1no. Maple reduce height of stem to 3m, 1no Birch – Fell at 2 - 4 Saracen Fields, Waldersalde. **Ratified** the Clerk's decision, after consultation with members, *Do not wish to object defer to the views of the Landscape Officer.*

16/502442/TPO TPO application to 1no.Large Hornbeam Group. One of the stems leans heavily towards the property and needs to be removed. 1no large Oak - Reduce back large stem by 15-18ft on the south side to remove the weight and mitigate the leverage towards the road. 4no. Cherry trees - Fell. On the northern side there 1no Cherry, 2no Birch - fell, 1no Ash - reduce height by 12ft at Alexandra Hospital, Impton Lane, Walderslade. **Ratified** the Clerk's decision, after consultation with members, *Do not wish to object defer to the views of the Landscape Officer.*

16/503214/TPO TPO application to 1no single stem Sweet Chestnut pollard to approx. 35ft and 1no multi stemmed Sweet Chestnut to approx. 35ft. Redsands Boarley Lane Sandling. **Ratified** the Clerk's decision, after consultation with members, *Do not wish to object defer to the views of the Landscape Officer.*

16/502026/FULL Proposed first floor side extension. 89 Badger Road Walderslade. **Ratified** the Clerk's decision, after consultation with members, *Do not wish to object.*

16/503160/FULL Erection of a single storey side and rear extension. 23 Woodlands, Walderslade. *Do not wish to object.* However members have raised concerns over the close proximity of the proposed extension to the boundary fence and believe this is not in keeping with neighbouring properties.
