# 6. **Planning Applications for Consideration – Decision**

## 20/502038/FULL Popesfield, Bearsted Road, Weavering, Kent

Variation of Condition 19 of planning permission 18/506656/FULL (Primary School and Special Educational Needs Secondary School) to include provision of a controlled pedestrian crossing point on Bearsted Road until such time that the upgrade works as part of the A249 Bearsted Road Improvement Scheme relevant to this development have been completed.

**Boxley Parish Council Response**: Boxley Parish Council have no material planning reason to object to this application.

Cllr Hinder reported that the schools would not be opening in September and the pupils due to start would go to other academies until the school opened.

It was noted that the number of pupils registered to start in September was well below those projected and confirmed the PC's view that there was no demand for a primary school in this locality. There is a concern that pupils would come from further afield and lead to an increase in traffic movements causing additional traffic issues.
