Boxley Parish Council still have grave concerns for the welfare of the wildlife on this site. The loss of habit connectivity for dormice is not mitigated by the provision of one rope bridge across the road. They will also be subjected to disturbance of nesting sites by the construction and use of the woodland by residents and their pets.

There has still not been any ecological survey for insect species on the site.

There has been a long period of activity with nuisance motorcycles on the site with the permission of the landowner. This has caused a lot of upset with residents in the area and must have done a lot of damage to the wildlife population (intentional?). Boxley's PCSO has reported that the permission has now been revoked by the landowner.

This is a site with numerous protected species on it and any development is going to cause devastation to their population.
