# Highways and Byways - DECISION

# 8.1 Highways Improvement Plan

The detailed report from KCC was noted. The Clerk was asked to acknowledge receipt with an expression of disappointment at the contents of the report. Action Clerk.

# 8.2 Junction 3 of the M2/Bluebell Hill

A meeting had been held on the 3/2/23 with MP Helen Whately, County Councillor Paul Carter, Peter Phillips from National Highways, Simon Jones KCC Highways, Cllrs C Sheppard, B Hinder and Alan Asseter from BPC and others.

The meeting was very encouraging. A programmatic approach was being taken. KCC were currently bidding for 200 million pounds to fund their planned improvements but would have to fund 15 percent of this total. It was acknowledged

that these improvements would only provide 3-5 years improvement on the junction before it was over capacity again. It was generally agreed that Bluebell Hill should be part of the Strategic Road network. Helen Whately would be meeting with the Ministry of Transport to discuss the outcomes of the meeting and would provide an update after the meeting.

# 8.3 A249 Bearsted Road Major Infrastructure Project

No further updates. Several planned meetings had been cancelled.

### 8.4 Boxley Village Traffic Improvements

Members of the Boxley Village Society (BVS) had attended the meeting to discuss this item. Concerns were expressed over the volume and speed of traffic. BVS requested a lorry watch scheme and it was agreed that BPC would support this. Action Clerk.

The installation of average speed cameras was discussed and the Clerk would look into costs and feasibility. Action Clerk

The Clerk would look at costs for speed gateways and more speed roundels. Action Clerk.

BVS had already spoken to the Nuventure bus company and bus drivers were being advised to drive more carefully through the village.

There was extensive discussion over the proposed Lidsing Development of 2,000 houses and the potential effects this would have on Boxley Village. Cllr Hinder recommended that BVS register with the Planning Inspector so that they could speak at the Stage 2 hearings in May. The Clerk/Cllr Hinder would send them the information needed. Action: Clerk/Cllr Hinder.
